DESCRIPTION OF WORK: The Shasta Valley Resource Conservation District (SVRCD) is acting as lead agency for this project, and the grantee is the City of Weed Fire Department. The SVRCD will administer the contract and serve as the primary contact during implementation.

This fuel mitigation project is located within and around the City of Weed in Siskiyou County, California. The treatment will protect habitable structures within the City of Weed and surrounding areas. The objective of this project is to provide immediate fuel mitigation to reduce fuel loading within the project area and to ensure a lasting effect on the community to reduce the fire hazard for many years after the project is complete. Funding for this project is provided by the California Department of Forestry and Fire Protection's Wildfire Prevention Program.

PROJECT TIMELINE:

- Bids Due June 18, 2026 at 2:00pm
- Contract award by July 15, 2026
- All activities must be completed by December 31, 2026

CONTRACTOR EXPERIENCE: This project requires that the contractor is experienced in performing vegetation removal work. References for similar projects may be requested as determined by the Project Manager.

CONTRACTOR OBLIGATIONS, LICENSING AND REGISTRATIONS: Contractor agrees to be bound by all the provisions of the California State Labor code and shall monitor all

contracts subject to reimbursement from this Agreement. Contractor must be licensed by the State of California.

PRE-BID SITE VISIT: No pre-bid site visit will be held for this project. Contractors may contact representatives of the SVRCD and the City of Weed regarding questions about the treatment units.

PROJECT ADMINISTRATION: All questions relative to this project prior to the opening of bids shall be directed to Anna Parry, Project Manager, at (702) 300-5952. It shall be understood, however, that no interpretations of the specifications will be made by telephone.
