GrizzlyCorps is an AmeriCorps Fellowship administered by UC Berkeley's Center for Law, Energy & the Environment (CLEE) that builds climate resilience for rural farm and forest communities in California.



We are seeking upcoming and recent college graduates who want to gain direct experience in sustainability and climate resilience while making a lasting impact in farm & forest communities across California.

WHY GRIZZLYCORPS?

The local farm and forest community experience provides critical insight into some of California's most pressing climate concerns.

Fellows will gain hands-on experience through GrizzlyCorps' two main tracks:

- regenerative agri-food systems
- fire & forest resilience

Each fellow will implement 1-6 capacity building projects.

- prescribed fire coordination
- technical assistant for farmers
- GIS database development
- outreach & event coordination
- develop project scope or proposals

BENEFITS FOR FELLOWS

- Professional development opportunities
- Climate change and field-specific trainings
- Field experience, with direct supervision
- Valuable hands-on community engagement and national service experience
- Annual living stipend of \$30,250, paid monthly over the 11-month period
- \$10,000 education award to be used toward further education or student loans (upon completion of full 1700 hour term)
- Student loan forbearance and interest accrual repayment of eligible student loans
- Health insurance & childcare assistance (if eligible)
- SNAP (CalFresh)
- Opportunities to develop professional contacts and mentors
