08.7 Review and discuss Meamber Fish Screen Project from CDFW, Resolution 23-010. A new grant has been awarded to replace the existing fish screen for the Hull and Meamber riparian irrigation diversion. **ACTION:** Approve Resolution 23-010. **MOTION:** Hirt, **SECOND:** Perkins, **Approved by Voice Vote: AYES:** Walker, Perkins, Hirt, **NOES:** None; **ABSTENTIONS:** None. **Motion Approved.**

08.8 Discuss a Siskiyou Farm Bureau request to be Lead Agency for a CDFW grant they received. Dowse and Walker lead a discussion of potential stockwater projects in Scott and Shasta Valley and CEQA responsibilities. By common consent, it was agreed by the Board that SVRCD will assist with this work.

### **Staff and Project Reports**

Brown discussed existing Water project updates including Bel Campo, NRZ, Huseman and monitoring. Mallory Pappas is sharing field work for monitoring now. She is leading the creation of a grazing workshop, planned in conjunction with our TMDL grant. We have recently received 6 new grants to further our water conservation and riparian habitat work.

Blessing gave a Forestry projects update including McKinley-Scott, West Mt Shasta, Wildland Mitigation Fund and others. Elk Flat and Dunsmuir are completed. Staff is taking fire safe training for the outreach portion of the West Mt. Shasta grant. A grant in Scott Valley at the Spenser Ranch is being planned as part of one of our grants. The Rainey Ranch will be a focus of forestry/water quality now that we have enough staff.

McGill reported that our two new Grizzly Corps members starting on September 12<sup>th</sup>.

Perry reported on planning work requested by SRWA and potential grant opportunities and strategies. Board advised that a new engineering study may be warranted.

### **Other Agency/Group Reports: None**

Walker reported on Water Board curtailment discussions and meetings. The public hearing was well attended and many agricultural producers from Scott and Shasta Valley gave testimony in person. More data is needed and SVRCD can assist.

Patterson reported on NRCS news. Agricultural Water (AGWA) in Scott Valley has requested direct funding for water conservation measures (pivots).
