10.3 Select a contractor for the Kilgore Hills, Spencer Ranch project. Blessing led a discussion and recommended selection of Buck Mason Contracting. 10.4 Biomass Joint Powers Agreement (JPA) Proposal. Dowse discussed a possible JPA for biomass opportunity. The JPA would increase capacity for biomass in Siskiyou County through a JPA between several RCDs in Northern California. An informational presentation to the Board is planned for our November meeting.

Staff and Project Reports

Blessing reported on forestry projects including West Mt. Shasta, CalOES, and various other projects. Grizzly Corps member Jose Alberola is assisting with our Horse Creek culvert replacement project. SVRCD is working with Siskiyou County on post fire treatments including possible spraying.

Dowse reported that the annual audit is finishing up with Smith and Newell. We are in good shape in that department. Decals, hats and vehicle magnets are coming to identify SVRCD staff in the field.

Perry reported for Brown that various pending grants are still being negotiated in the contracting phases. These include CDFW for Huseman Planning, and WCB, NFWF (NRCS) for NRZ implementation. Monitoring Reports are almost complete. We will be leaving some equipment in the river over the winter to collect temperature and DO data. Spawning chinook are visible in the river. A riparian workday is planned at Nelson Ranch.

McGill reported on the pre-bid walk through at Hill Road for the West Mt. Shasta project. This will make the project more visible to the neighborhood. We are working on the Fall 2023 Newsletter.

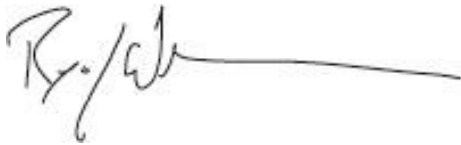
